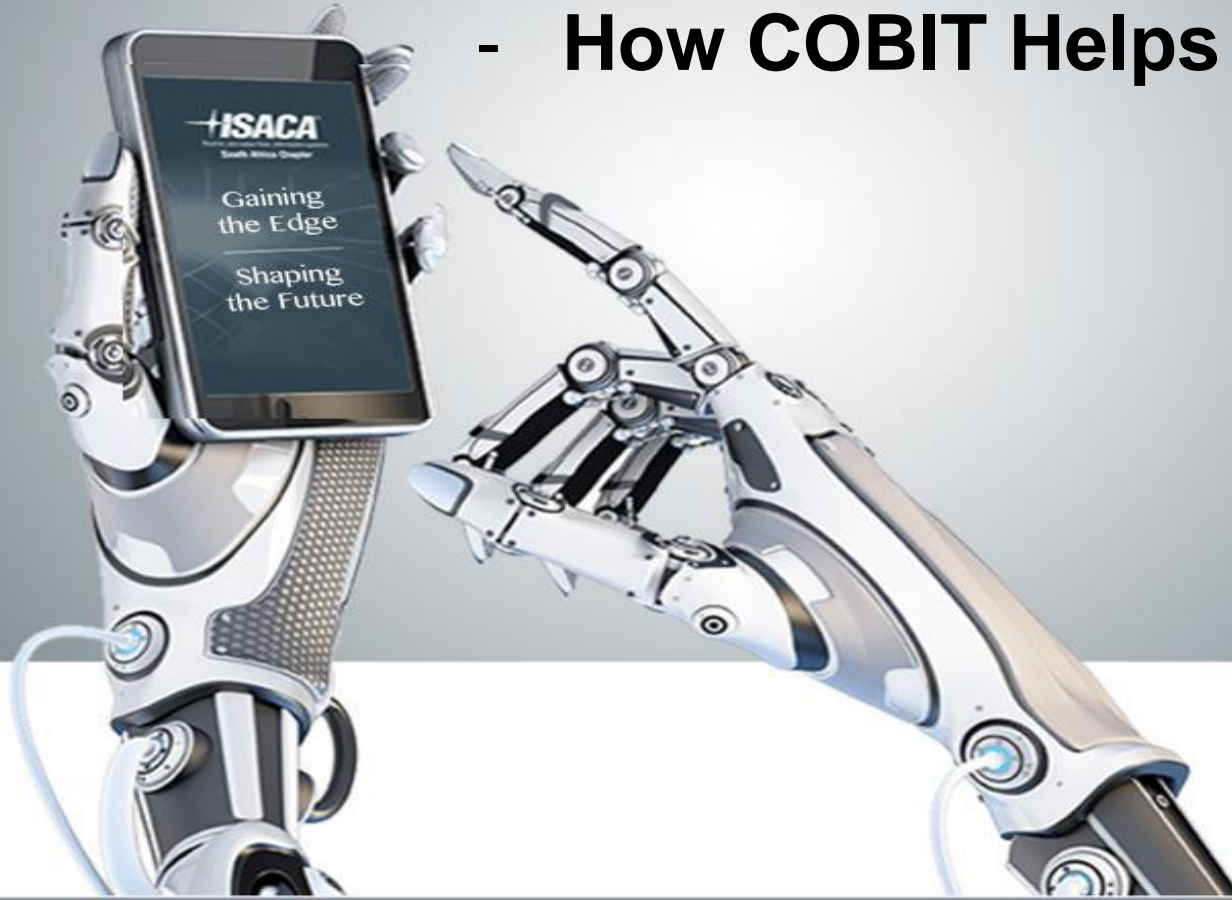

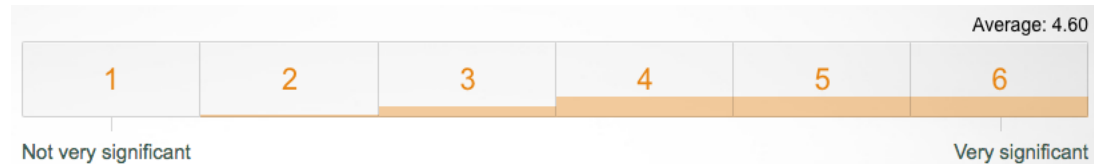

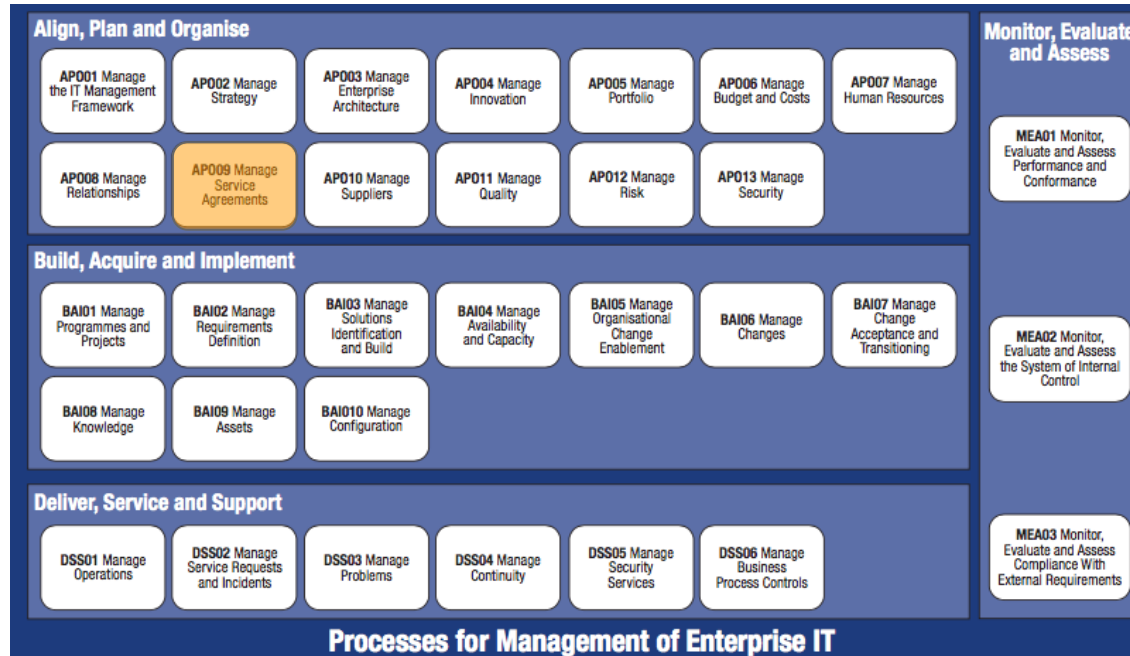
Defining SLAs in technical delivery terms

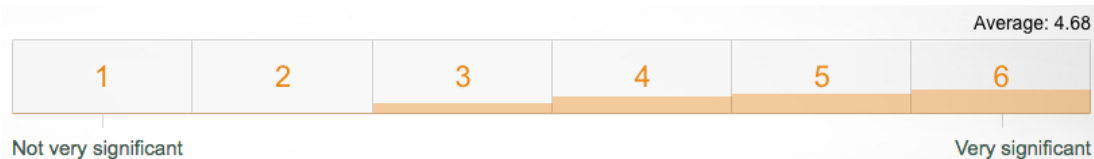

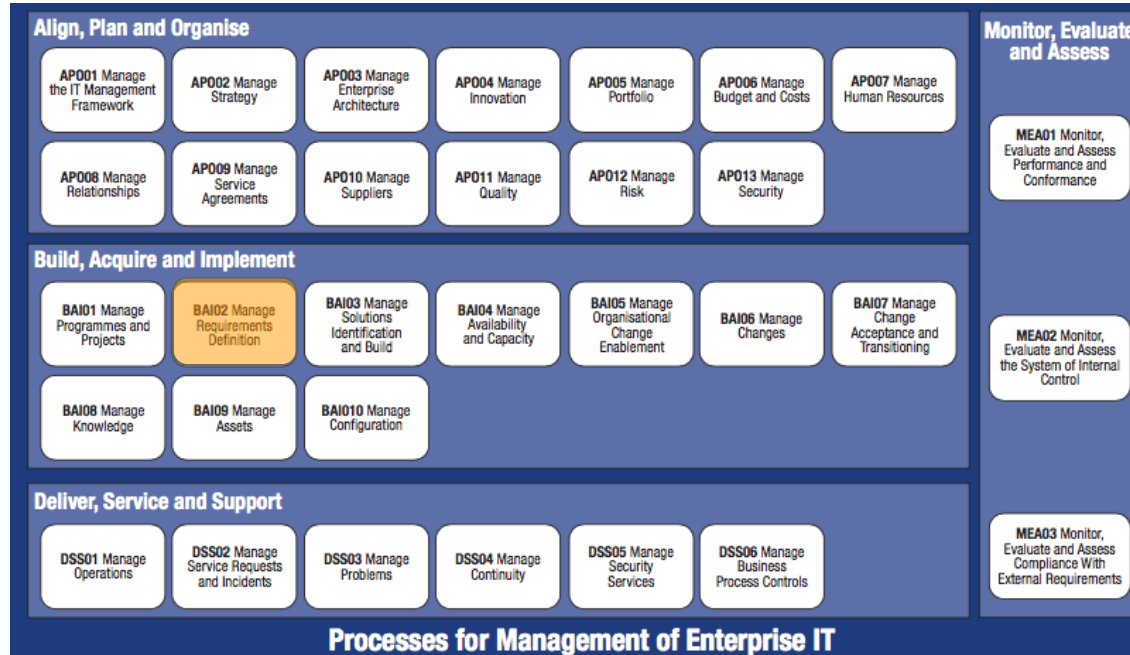
Defining requirements as a solution description

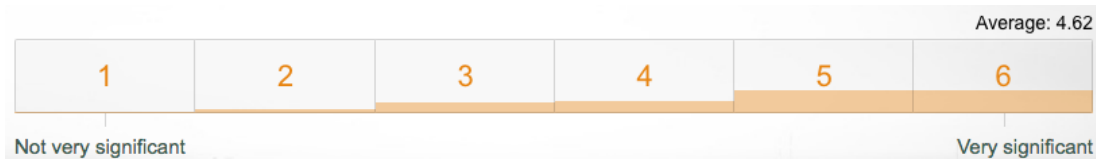

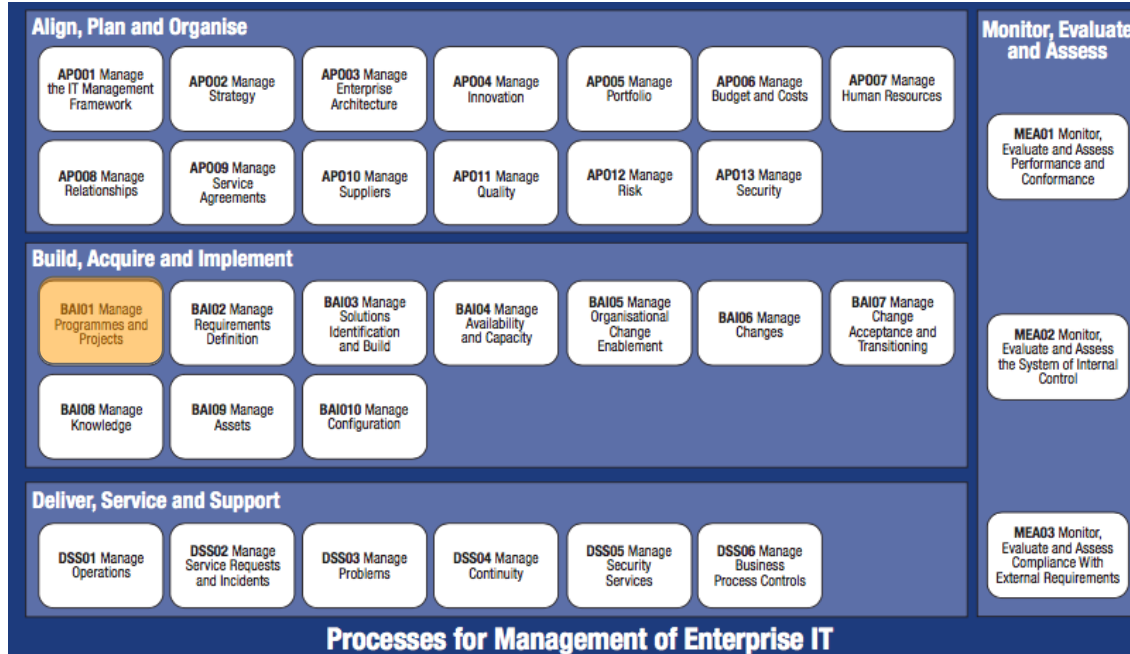
Defining business changes as “IT Projects” after the IT solution

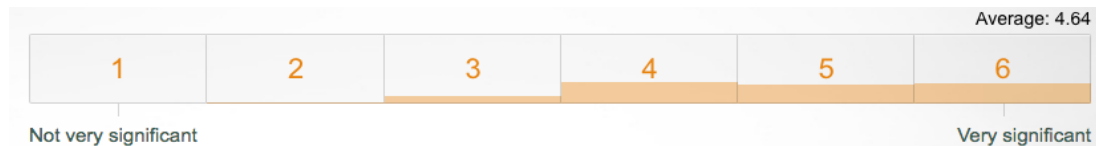

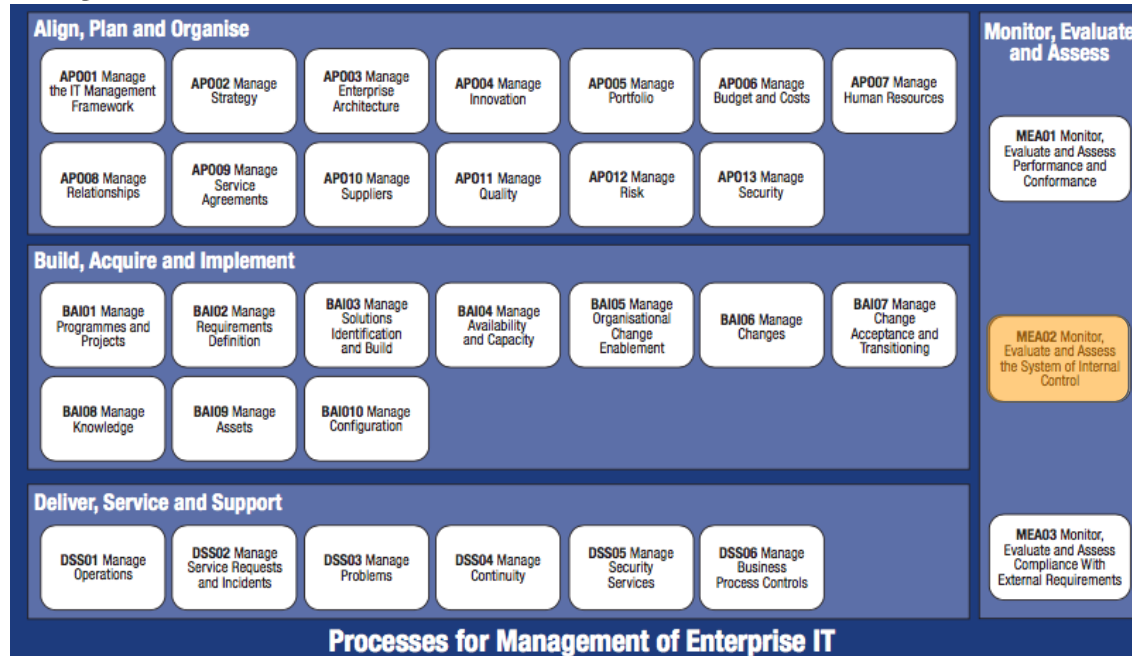
Reacting only to audit findings

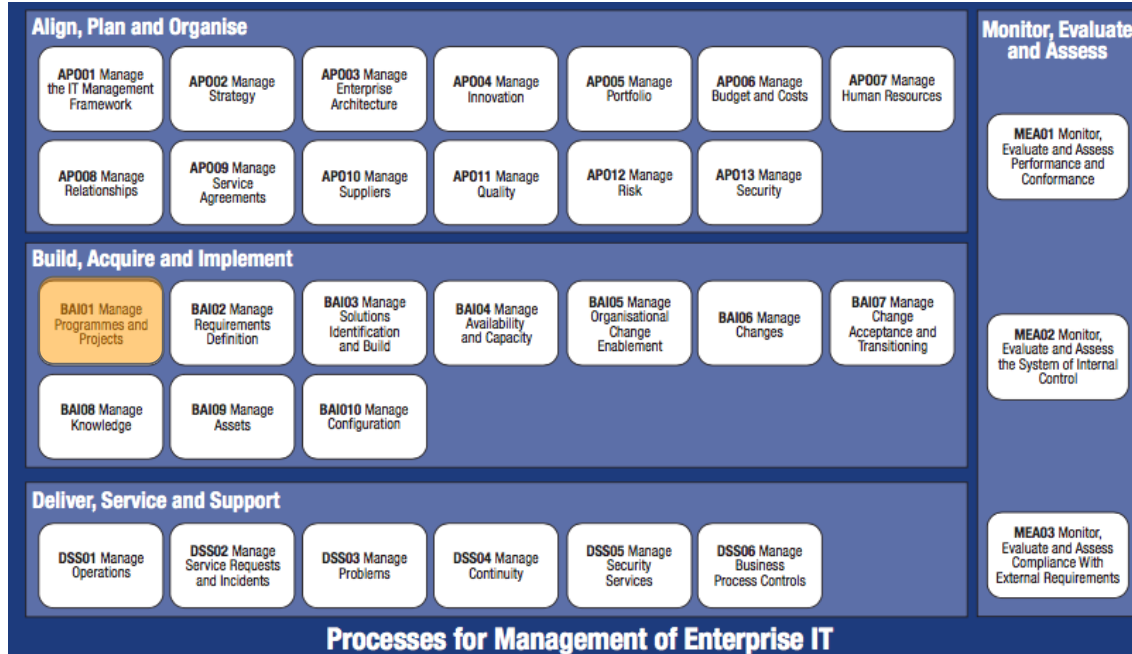
Failing to use a business case to monitor desired outcomes and benefits.

Failing to appoint a senior business executive to drive the management of information security

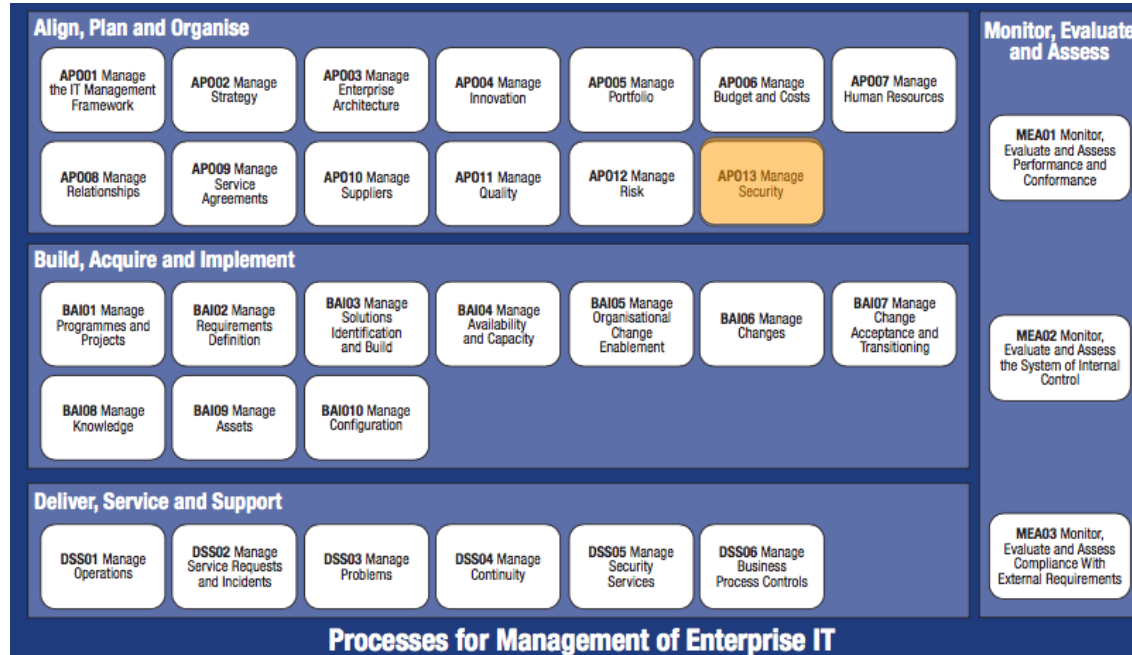


“In most cases, decision making is left to technicians, rather than business executives.”

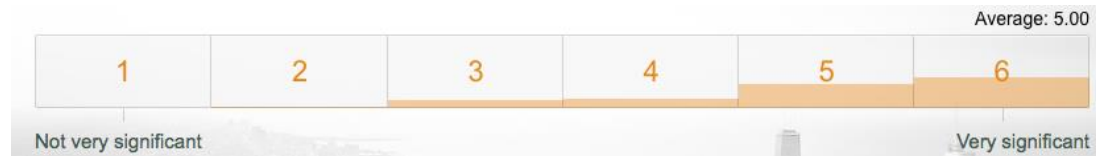

Assuming IT is only for the “IT Function”



RACI Charts

Use RACI charts which show that business accountability and engagement runs across all IT processes.



R

Responsible

Who will do the task, who's assigned?

A

Accountable

Who has the authority to take decisions?

C

Consulted

Stakeholders identified? Who can tell you more about the task?

I

Informed

Who depends on this task? Who needs regular updates?

Not appointing a business owner / sponsor to be accountable for IT enabled business changes

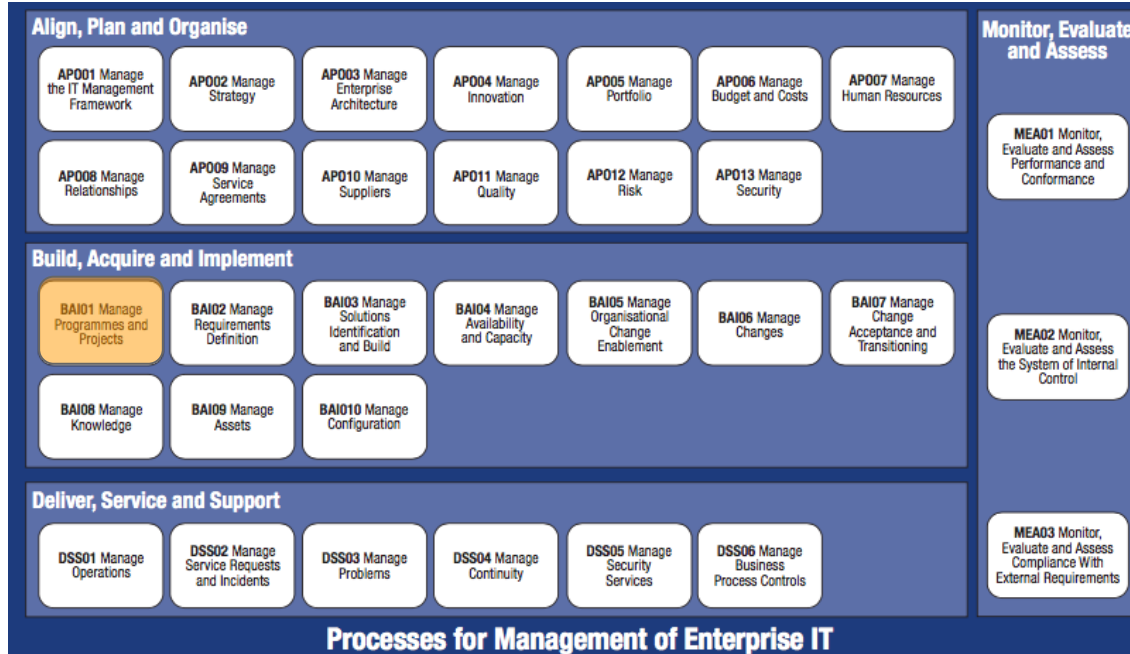


“No commitment from business, poor definition of requirements and limited business engagement in driving the benefits.”

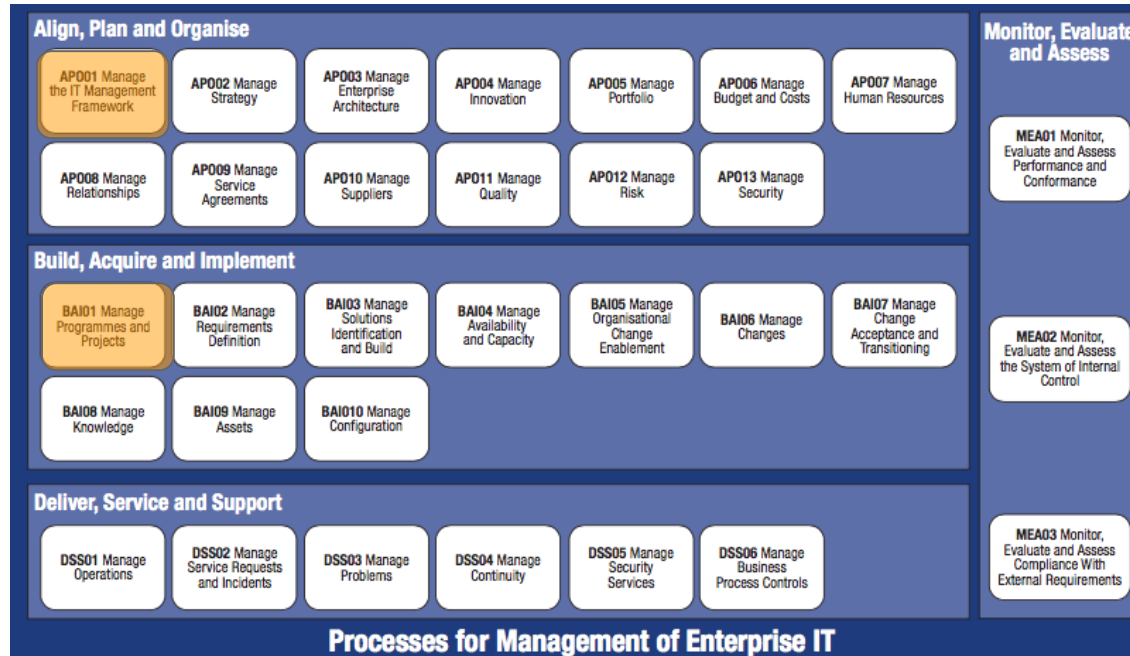
Not appointing the right stakeholders to IT steering committees
